A Christmas message from MinEX

Hi, only six more sleeps until Christmas! So, let me just quickly highlight some things MinEx has been behind or supporting this year to make you and your operation safer and which you may wish to reflect on during your holidays.



RCS survey

During Oct-Nov MinEx conducted a survey of its database to establish what sites are doing in terms of identifying hazards associated with exposure to Respirable Crystalline Silica (RCS), assessing the risks, and conducting health surveillance. The purpose was to identify how Minex could assist the extractives sector in their understanding of hazards associated with worker exposure to RCS. 159 respondents completed the survey. A summary of results shows that:

- 84% of respondents conduct health assessments of workers (79% include lung function test)
- 75% of respondents are aware of the ACOP on Air Quality in the Extractives Industry
- 55% of respondents have conducted dust monitoring (80% in accordance with relevant standards)



While a large number of respondents are conducting health surveillance of workers, a number of sites are not conducting dust monitoring and therefore may not have adequately assessed the risks of RCS exposure to workers.

Next steps will include the communication of results to participants, and the wider sector. MinEx has developed a training package on Worker Health which was recently delivered to a group of alluvial gold miners on the West Coast. This package has been made available to industry and professional associations within the extractives sector. MinEx has also released a [Guide to Worker Health in Extractives](#) which is now on our website. We also plan to develop a flyer on RCS for industry.

Health and Safety Template

We've provided small quarries with a [Health and Safety Template](#). Please review this as you start any New Year planning. It's designed to help you manage the risks to you, your staff or workmates.



Mentors now available

Consider taking up our mentoring service in 2018. Oral exam pass rates for B grades have now gone to 60% when a few months ago, that was the level of failure. Our mentors, stretching from Northland to Southland have generously contributed to that improvement. If you or one of your staff need help with exams, we may be able to provide some local assistance. Just ask us.



Your CoCs must be in place

A crackdown on having CoCs in place is emerging. We are now nine months on a year past the time when every mine and quarry, no matter how small, was required to have someone with a CoC in charge of a site. WorkSafe is starting to use prohibition (closure) notices. This can only intensify in 2018. Don't think you can remain below the radar or continue to offer a 'we are trying' explanation.



Help us to help you.



We issued a call earlier this year for people to share their 'near miss' experiences and have had a good response. Every extractive site has these 'OMG' moments where someone narrowly escapes being seriously harmed. If we share these, other sites can avoid repeating such incidents with potentially deadly consequences.

So as you ease into 2018, please take a few minutes to email or call me about your site's 'near miss' experience(s). I give my word that the information will not be on-passed and will remove any details that can identify a site.

In the interim, I wish you, your staff and workmates and families every best wish for a safe and happy Christmas and holiday.
